***April 21, 2025, meeting minutes were read by clerk. Lee motioned to accept the minutes as written with corrections, and Darrell seconded the motion. Minutes accepted. Unanimously passed.***

**General Business**

**The Mosquito Sprayer-** Mayor stated that we have a correction on Mosquito sprayer price. It is \$17,000 without the cost of the chemicals. We need to figure out what we are going to do. She talked to Parksley and their computer board has gone up and they have no sprayer. DO we hire someone to spray? Beverly stated she would rather hire someone to spray than worry about the upkeep and all the other stuff that comes with it. No maintenance.

**Electric at Harbor-** Mayor contacted Jack Tarr-Electrician who gave us quote for the Harbor electric repairs to let him know we were approved for the monies. Grant for \$48,000  
The mayor stated we are still awaiting reimbursement for the pump out station and the health department.

**Nature Conservancy-** Mayor had lunch with them and they are going to start with the kickoff of the castles. We need to get the word out for volunteers to help.

**Little Libraries-** Ann Schu has taken hers down and Ann Martin and her took down the one at Donna's home.

**Budget- 2025-2026-** Budget was reviewed by Mayor with explanation for all revenue and expenditures. Wayne motioned to approve the budget to be advertised for 2 weeks in the Post newspaper and Beverly seconded the motion. Unanimously passed.

**Town Expenses-** This was handed out to all and explained by category.

**Town Sign-** Erosion is taking the land under the sign and the ditch. The mayor called David Pruitt, and he is checking the right of way to see if they can fill it there with class II rock. She will follow up.

**James Elliott-** Town Attorney- He will begin to collect past due taxes with a 10% penalty and 10% interest. Hopefully he will take over our ordinances, etc.

**STR- Lee** asked where we are on the 10 capped Str's. The mayor stated all Special Use Permits are due June 30, 2025, and we would know if all were renewed by the July meeting.



**Playground Equipment**- Beverly asked if we had monies set aside for playground equipment. The mayor stated we did not, we would have to get a grant. She also stated that if you visit Joyce Linton or walk past Martha Jane's house, you will see spoiled foods everywhere around her house and in Joyce's Lane. Can we contact the health department? Bryan asked if she was sure, it was her dumping the stuff and Beverly said "Yes."
